Release and Waiver of Liability and Indemnity



In consideration for being permitted to utilize the facilities, services, and programs of the YMCA (or for my children to so participate) for any purpose, including but not limited to observation or use of the facilities or equipment, or participation in any program affiliated with the YMCA, without respect to location, the undersigned, for himself or herself and such participating children and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the YMCA for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated programs have been inspected carefully considered and that this undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use, or participation.

The undersigned is aware of the different types of activities, equipment, and facilities offered by the YMCA and is aware of the risks inherent in the participation in such activities and use of such equipment and facilities.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE YMCA FOR ANY PURPOSE, INCLUDING BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE YMCA, WITHOUT RESPECT TO LOCATION, THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

- 1. THE UNDERSIGNED ON HIS OR HER BEHALF AND BEHALF OF SUCH CHILDREN, HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** the YMCA, and all branches thereof, its directors, officers, employees, and agents (hereinafter referred to as "releases") from all liability to the undersigned or such children, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to releases or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participating in any program affiliated with the YMCA, without respect to location.
- 2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned or such children in, upon, or about the YMCA premises or in any way observing or using any facilities or equipment of the YMCA or participating in any program affiliated with the YMCA whether caused by the negligence of the releases or otherwise.
- 3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE** to the undersigned or such children due to negligence of releases or otherwise while in, about, or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA.

The undersigned gives permission to the Charlotte County Family YMCA to use, without limitation or obligation, photographs, film footage or tape recordings that may include the undersigned's and such participating children's image(s) or voice(s) for purposes of promoting or interpreting YMCA programs.

THE UNDERSIGNED further expressly agrees that the forgoing **RELEASE, WAIVER AND INDEMNITY AGREEMENT** is intended to be as broad and inclusive as is permitted by the law of the State of Florida and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.

MEMBER CODE OF CONDUCT

Using the principles of Caring, Honesty, Respect, and Responsibility as a guide, we have implemented the following Member Code of Conduct to ensure that all who participate in the Y enjoy a safe, welcoming and comfortable environment. We ask individuals to behave in a manner that upholds these principles at all times when they are in our facility or participating in our programs.

Specifically, actions that do not adhere to these guidelines and are not-permitted include:

- Wearing inappropriate attire, including swimsuits and workout attire that are too revealing and clothing with vulgar/profane writing or language
- Using angry or vulgar language including swearing, name-calling, or shouting
- Making physical contact with a person in any angry or threatening manner
- Demonstrating any form of sexual contact, behavior or activity
- Harassing or intimidating by words, gestures, body language or any other menacing behavior
- Stealing or destruction of property
- Carrying or concealing any weapons, devices or objects which would be used as a weapon
- Using or possessing illegal drugs or alcohol in or on Y property or at Y-sponsored programs
- Demonstrating any other conduct of an inappropriate, threatening or offensive nature
- Refusing to adhere to staff requests
- Use of photography, including camera phones, unless specifically approved by the Y leadership team at the Welcome Center
- Smoking on Y property

Access Restrictions: The protection of members and guests who are participating in programs or are using Y facilities is of paramount concern to the Y staff. Therefore, we reserve the right to deny access or membership to any person who:

- Is a registered sexual offender
- Has pled guilty to or has been convicted of any crime involving sexual abuse
- Has pled guilty to or has been convicted of any crime against persons such as child, spousal, or parental abuse
- Has pled guilty to or has been convicted of any offense relating to the sale or transportation of illegal narcotic, habit-forming, or dangerous drugs.
- Is presently clearly under the influence of intoxicating beverages or behavior-modifying drugs

Members and guests are encouraged to be responsible for their own personal comfort and safety and to ask any person whose behavior threatens their comfort to refrain from doing so. If you feel uncomfortable confronting the person directly, please report the behavior to a Y staff person immediately.

The appropriate Y staff member will investigate all reported incidents. Suspension or termination of membership privileges may result from a violation of the Code of Conduct.
